20. Notify those residences falling within the limits of 19 on this application with the intent to build and attach copies of notifications.
21. Attach Nutrient Management Plan as per Taylor County Code 63.
22. Attach all contracts to spread manure and other wastes generated at facilities if insufficient land is owned as per Nutrient Management Plan. Use Appendix A Form.
23. Attach or provide when obtained the following permits: (a). All building permits, Township and Taylor County(b) County & Township culvert Permits (c)Manure Storage Permit, Taylor County (d)DNR Storm Water Construction Permit (e)DNR High Capacity Well Approval.
24. Application shall be done quadruplicate and bound in a 3 ring notebooks with sections noted and tabbed. All pages will be numbered. Each page of one copy will be initialed by both a representative of the Livestock facility and a representative of the Town Board and the date noted on the index or cover page.
